Report on the Audit of the Financial Statements

Opinion

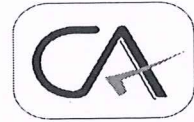

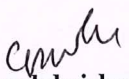
Inherent Limitations of Internal Financial Controls Over Financial Reporting

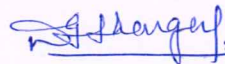

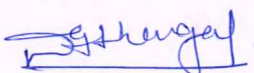

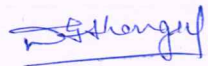
